Dear families, We look forward to sharing a fun-filled Vacation Care Program with you all.

By signing the **Booking Form**, you acknowledge, agree and consent to activities/experiences that may include travel to and from venues by various means and may involve contact with members of the general public. In the event of illness or injury suffered whilst attending, you authorise educators, at their discretion, to obtain medical attention for your child and you will be responsible for associated costs (reasonable efforts will be made to contact you).

You understand that session times are 7:30am-6pm & you are liable to pay fees as per the Fee Schedule [including any late or cancellation fees if applicable].

Please Note – Risk Assessments are available for all excursions. Please ask a team member if you would like to view them.

## **Booking Process -**

Places are limited, please return your child's completed enrolment form as soon as possible to <u>asc@collegiate.tas.edu.au</u> or hand directly to a team member at After School Care. *Please note – late bookings may not be catered for.* 

### Fees/Cancellations/Absences -

Where your child has not attended Collegiate OSHC for 8 weeks or more, or has previously had a casual booking, you may be required to re-confirm your child's enrolment via MyGov to ensure any relevant CCS is applied. Please check your MyGov App.

You are liable to pay fees for the care of your child/ren as per the Fee Schedule – including applicable cancellation fees.

Fees are inclusive of excursions, bus costs, resources and afternoon tea unless otherwise stated on the program.

# 'What You Need' -

Please ensure your child brings the following clearly named items every day......

- A wide brimmed sun-smart hat clearly named (between September and April and no caps please). Coles brand 50+ Sunscreen is provided.
- Lunch and morning tea everyday (unless otherwise stated in the program. NO lunches that require heating please).
- Afternoon tea is provided.
- A water bottle clearly named.
- Clothing Spare clothes/underwear depending on the nature of the day's experiences and your child's personal needs. (We do not have spares clothes).

# Program description -

The description on the program is the main attraction of the day. Throughout each day children will be involved in, and offered, a huge variety of experiences.

### Changes to the Program -

The Service reserves the right to make changes to the program due to weather conditions, unforeseeable circumstances, or minimum numbers. Where possible, parents/guardians will be notified prior to any changes [via email, phone or on arrival].

### Health and Wellness - COVID - 19

Children cannot attend if they are showing any cold or flu-like symptoms or within 24 hours of any gastro symptoms.

#### **Personal Electronics-**

In line with the St Michael's Collegiate Digital Technologies Policy, and to support a safe environment for all the children attending Vacation Care, it is requested that all personal electronics are left at home. This includes smart phones, watches, and all other Information Communication Technology (ICT) devices. Where an ICT device is brought to the Program, it will be stored in a secure location until collection.

# **Other Information -**

The Vacation Care Program will be displayed each day. Please read each of the daily activity descriptions carefully as particular days may require specific clothing or other important information.

# **Medication** -

All children with a known medical condition enrolled in the program must have a **Medical Action Plan**, signed by the Doctor and provided at enrolment. If medication is required to be administered to your child during Vacation Care a completed **Medication Consent Form** will be required to be filled at commencement. *Please note: Only a pharmacist label with your child's name, current date, dosage and name of medication will be administered.* 

### **Excursions** -

We strive to leave on time. To support this, we ask that you **arrive at Vacation Care no later than 15 minutes prior to our departure time.** (Times are advertised on the program). Unfortunately, we cannot be responsible for late arrivals.

All excursions meet the legal ratio of 1:15, at times we will have extra Educators to accommodate the day's activities.

### Behaviour -

To support the enjoyment and safety of all children and educators, we reserve the right to refuse access to the children who do not act in accordance with our behavioural and safety expectations.

# Sign In & Out -

The iPad is situated at the entrance to Alkira, along with QR codes displayed at the doors. All parents or authorised persons who deliver and collect their child are required to sign them in and out.
